Governing Law: The Agreement shall be governed by the laws of the State of California.

Entire Agreement: This Agreement contains the entire agreement between the parties relating to the rights and obligations contained herein, and any representations, negotiations, or agreements among the parties are merged into this Agreement. No subsequent modification or amendment between or among the parties shall be effective unless in writing signed by all parties to this Agreement who may be affected by such subsequent modification or amendment hereto.
