CITY OF CUPERTINO ATHLETIC FIELD USE PERMIT DECLARATION

I, Art Zimmermann (Print full name of person) declare as follows:

- I certify that I have been provided a copy of the City of Cupertino Athletic Field Use Policy ("Policy"). I have read and understand the Policy. I agree to utilize the fields authorized in the attached City of Cupertino Athletic Field Use Permit ("Permit") in accordance with the guidelines set forth in the Policy and this Permit. I fully understand that any violation of the Policy and/or terms of this Permit as determined in the sole discretion of the City of Cupertino ("City") may result in the immediate suspension and/or termination of this Permit.
- All participants, coaches, agents, volunteers, or members of De Anza Youth Soccer League (Print full name of organization or entity) who have or may have contact with minors shall complete fingerprinting and criminal background checks via live scan service ("Live Scan") performed at the Santa Clara County Sheriff's Office. On behalf of said organization or entity, I certify that the aforementioned persons that have or may have contact of any kind with minors who use the fields in relation to this Permit have completed Live Scan. In the event that such a person has not completed Live Scan at the time this Permit is submitted to the City, I further certify that said person shall complete Live Scan prior to any contact with minors.
